This letter presents the progress made by the PRP Group during February 2004 on RI/FS and IRAM Development at the Astoria Area-Wide Petroleum Site in Astoria, Oregon. This work is being conducted in response to DEQ Order No. ECSR-NWR-01-11.

WORK COMPLETED DURING FEBRUARY 2004

A response to DEQ comments on the work plan for investigation and decommissioning of product pipelines was completed, allowing us to schedule field work. Field work is tentatively scheduled to begin the week of March 29.

Data validation for ground-water data collected during the First Quarter 2004 (2nd Round) monitoring event was initiated in February. Water levels in all monitoring wells were measured in February. Preparation of the Fourth Quarter 2003 (1st Round) Ground-Water Monitoring report was completed in February.

The Fourth Quarter 2003 Quarterly Storm Water Monitoring report was completed in February. Storm water sampling for the First Quarter 2004 monitoring event was completed in February.

Comments from the DEQ on the Vapor Inhalation Pathway Assessment work plan were received in February.

A response to comments on the design and specifications for the hydrocarbon seep IRAM enhanced boom and storm sewer rerouting was initiated in February. A response to DEQ's comment letter dated January 29, 2004, will be provided in an upcoming submittal. Preparation of a work plan for collection of data upland from the hydrocarbon seep was continued in February. The interim product removal activities associated with the hydrocarbon seep IRAM were continued in February.

A meeting of the PRP Group technical representatives was held on February 10.

WORK PLANNED FOR MARCH 2004 AND APRIL 2004

Implementation of the work plan for investigation along product pipelines is scheduled for the end of March or early April, subject to DEQ approval of the PRP Group response to comments.

The quarterly ground-water monitoring report for the Fourth Quarter 2003 (1st Round) monitoring event will be submitted in March. The water-level monitoring program will be continued in the complete monitoring-well network in March and April. The well construction documentation will be submitted in March. Analysis of data from the ground-water sampling for the First Quarter 2004 sampling event (2nd Round) will be conducted in March and April.

A report in the 1st Quarter 2004 storm water monitoring event will be completed in March and April following receipt and validation of laboratory data.

The Level 1 ecological evaluation is scheduled to begin in March and continue through April.

Comments from the DEQ on the Vapor Intrusion Pathway Assessment work plan will be addressed in correspondence to DEQ in March. Field work related to this work plan will be initiated within three weeks of resolution of comments from DEQ.

A work plan to fill data gaps related to evaluation of the hydrocarbon seep at Slip 2 will be prepared during March and April. Implementation of the IRAM will be scheduled upon resolution of comments from DEQ. The IRAM construction is anticipated to begin in April. The interim product removal activities associated with the hydrocarbon seep IRAM are scheduled to continue in March and April.

PROBLEMS ENCOUNTERED AND RESOLUTIONS

There are no problems requiring resolution in February.
